#### DESCRIPTION

**KEY RESIN #517** is a chemically resistant, 100% solid, two component epoxy binder resin. The **KEY RESIN #517** is specifically designed for troweled decorative mortars and slurries. The stain resistance, superior clarity and wetting properties brightens the color of natural stone aggregates. It is essentially odorless and can, therefore, be used in occupied areas.

# APPLICATION

#### SURFACE PREPARATION

Surface Preparation is the most critical portion of any successful resinous flooring system application. All substrates must be properly prepared as outlined in **KEY RESIN COMPANY'S TECHNICAL BULLETIN #1**. Work must be performed by trained or experienced contractors or maintenance personnel.. #### INSTALLATION

#### **CLEAN UP**

Clean skin with soap and water. Tools and equipment should be cleaned with xylene or lacquer thinner.

#### COVERAGE

**KEY RESIN #517** resin will yield approximately 10 mils when spread at 160  $\text{ft}^2$  per gallon. Consult installation instructions for coverage on various mortar systems.
