



DESCRIPTION

KEY INDUSTRIAL is a heavy duty, trowel applied polymer modified flooring system consisting of acrylic polymer, graded aggregates, and cement. Typically installed at ¹/4" or thicker, **KEY INDUSTRIAL** conforms to the requirements of military specification MIL-D-3134, type II, class 1.

KEY INDUSTRIAL may be sealed to meet your facility's needs to enhance abrasion resistance, gloss retention, and non-skid properties. For chemical resistant applications, specify **KEY INDUSTRIAL-HP**.

KEY INDUSTRIAL can be installed with an integral cove base for areas requiring seamless wall to floor coatings. It is a breathable system making it an ideal solution for areas exhibiting moisture vapor transmission. Contact your **KEY REPRESENTATIVE** for specification assistance.

KEY CONSIDERATIONS

- Substrate temperature must be a minimum of 55°F (Low temperature cure system available on request).
- Substrate must be free of dirt, waxes, curing agents, and other foreign materials.
- All control joints and expansion joints in the substrate must be revealed with the appropriate divider strips in the topping.
- Movement of substrate cracks may transmit through system.

TYPICAL USES

KEY INDUSTRIAL is used in heavy traffic and production areas such as manufacturing plants, loading areas, processing and preparation areas, machine shops, and laboratories.

APPLICATION

Concrete surfaces must be in sound condition and properly prepared prior to any **KEY RESIN COMPANY** flooring system installation. Refer to **Key Resin Company Technical Bulletin #1** for specific preparation guidelines.

Installation of **KEY INDUSTRIAL** involves several steps including priming, troweling base toppings, grouting, and sealing. For specific installation guidelines consult **Key Resin Company's Installation Instruction Manual**.

MAINTENANCE

After completing the application of **KEY INDUSTRIAL**, the installer should provide the owner with maintenance instructions. If floors become slippery due to animal fats, oil, grease, or soap film, clean and rinse thoroughly.

KEY MORTAR INDUSTRIAL is easily cleaned with neutral soaps or detergents. Routine mechanical scrubbing is recommended for all surfaces having a non-skid texture. Waxing is optional. Long periods of heavy traffic may cause wear patterns necessitating a maintenance application of a finish coat.

COMPOSITION

KEY INDUSTRIAL combines portland cement with an acrylic emulsion and graded aggregates. A wide selection of finish coats is available to meet various exposure requirements.

COLOR & AVAILABILITY

KEY INDUSTRIAL is available in a variety of standard colors. Custom colors are available subject to laboratory approvals, minimum quantities, lead time for production and increased cost. Colors will not fade or wear thin.
