

DESCRIPTION

KEY EPOCON SL is a 1/8 inch self leveling moisture vapor control system utilizing **KEY EPOCOAT** technology, a unique water-based epoxy which allows the contractor to install polymer resin floor systems and other moisture sensitive floor coverings on new concrete (5 days old) without fear of moisture entrapment. **KEY EPOCON SL** is applied in a two coat application. **KEY EPOCOAT** is the primer/basecoat used in **KEY EPOCON SL**. **KEY EPOCON SL** reduces the passage of water vapor and moisture through slabs on, above or below grade, thus eliminating delamination and blistering of adhesives, floor coverings, resin floor systems, epoxy terrazzo and coatings. **KEY EPOCON SL** controls water vapor transmission levels for the installation of most floor covering systems, including VCT, sheet vinyl, carpets, wood, laminates, polymer resin flooring and epoxy terrazzo.
